

#### **Community Services Block Grant (CSBG)**

#### What is CSBG?

The Community Service Block Grant (CSBG) provides critical funding to Community Action Agencies (CAAs) to operate programs addressing the causes and condition of poverty under three national goals:

<u>Goal 1:</u> Individuals and families with low incomes are stable and achieve economic security.

<u>Goal 2:</u> Communities where people with low incomes live are healthy and offer economic opportunity

<u>Goal 3:</u> People with low incomes are engaged and active in building opportunities in communities.

The Community Services Block Grant (CSBG) <u>does not provide direct grants to individuals</u>; CSBG does not charge a fee for receiving a grant. #### **CSBG Income Eligibility**

Eligibility for Community Services Block Grant (CSBG) funded services may vary depending on sources of income and other factors. Please contact your local community services agency to determine your eligibility. CSBG income eligibility levels are currently set at 200% of the Federal Poverty Guidelines, as defined here: https://aspe.hhs.gov/poverty-guidelines.

## **Community Action History**

- Community Action was founded in the Economic Opportunity Act (EOA) of 1964 as part of Lyndon Johnson's "War on Poverty".
- The EOA also funded programs like Head Start, Job Corps, Vista, etc.
- Agencies were directly funded by the Federal Government.
- The EOA recognized that poverty is not the same around the country, and local communities need to be empowered to address the unique causes and conditions of poverty that exist in their communities.

## **Moving From EOA to CSBG**

- ➤ In 1981, Reagan replaced direct funding with the Community Services Block Grant Funding to go directly to State Offices, who are responsible for oversight and administration of CSBG and CSBG Eligible Entities
- > Federal government oversees state offices
- > The CSBG Act was last reauthorized in 1998
- ➤ Late 2021 and early 2022 included current efforts for CSBG Reauthorization

### What are States required to do with CSBG?

- Must allocate at least 90% of its federal CSBG allotment to CSBG Eligible Entities.
- May use \$55,000 or 5% (whichever is greater) for state CSBG administrative costs.
- > Remaining funds ("discretionary funds") must be used for CSBG authorized purposes.
